

#### **IN ANY CASE**

- APPLY FOR A PERSONAL IDENTIFICATION CODE NECESSARY TO PARTICIPATE IN EU FUNDS
- ALWAYS PLAN IN ADVANCE; ESPECIALLY FOR CONSORTIUM PROJECTS. THE BIGGER THE GROUP THE BIGGER THE COORDINATION PROBLEMS + DELAYS
- ALWAYS FILL IN EVERY BOX OF THE APPLICATION: LEAVE NO STONE UNTURNED
- HAVE YOUR FINANCIAL RECORDS AT HAND (PAST 5 YEARS)
- AVOID REPETITION EXCEPT OF CRUCIAL, SELLING-POINT KEYWORDS (I.E.: CURRENCY AGNOSTIC; USER OR COSTUMER CENTRIC, etc.)
